You can set up monthly recurring ACH payments**, make a debit/credit card payment, or make a one-time only payment online using your bank account and routing number (e-check). **The e-check service is free of charge.**

Go to <https://www.collins-mgmt.com/alliance> to set up your account. First-time users will need to register by providing information found on the bottom line of your payment coupons:

- (A) Management Company ID: **7443**
- (B) Association ID: **without the leading zeroes,**
- (C) Property Account #: (your HOA account number **without the leading zeros**)

*** Please note: If your assessment amount changes and you are on autopay with Alliance Bank, your assessment amount will be changed accordingly. However, if you are using your own online bill-pay, you will be responsible for updating the amount yourself.*

Your Bank's Bill Pay Service and Personal Checks Sent by Mail

To sign up with your bank's bill-pay, call or login to your bank's website and ask for/look for bill-pay services. Please make sure any bill-pay or personal checks meet the following criteria:

- 1) Make your payments out to the name of your HOA
- 2) Reference your HOA account number on the payment or on the memo line

Overnight Delivery of Checks and In Person at the Collins Management Office

Please note that your payment is not considered "received" until Alliance Association Bank receives it, not Collins Management. To avoid processing delays, you are encouraged to mail your payment directly to Alliance Association Bank; however, you may drop off your payments in person to our office. Checks will be mailed to Alliance Association Bank at the end of each business day. For security purposes, **we do not accept cash.** We only accept cashier's checks, personal checks and/or money orders.

For overnight deliveries of your payment, please mail your check, payable to the name of your HOA, along with your coupon, to **c/o Collins Management, 500 Alfred Nobel Drive, Suite 250, Hercules, CA 94547.** **Note:** Overnight deliveries of payments are only necessary when you are at risk of receiving a late fee. Please write your account number on your check.
